# Investor Awareness Program: An Insightful Guest Session



Mr. Chirag Vaya, a finance expert and a registered advisor with IRDA & AMFI, was on-board to share his insights and guide the students of finance on investments and mutual funds. He is working as a Vice-President at one of the prominent commercial banks in the industry. His varied experience of 13+ years in the industry helped students understand the traditional to modern approach of investing in India. Mr. Vaya began the session by interacting with the students to get a grasp of what the students understand about mutual funds. He then explained what mutual funds are, what their different types are and the benefits of investing in mutual funds.

He explained that the role of a fund manager is to invest the cash the investors have contributed, and the fund manager's goal depends on the type of fund. The session was very informative, and the students learnt a lot about mutual funds and the role of a mutual fund manager. They were able to understand mutual funds from the perspective of an investor as well as a manager.

# Mindful & Rolling Activities As A Financial Regulator

To get the most of a subject, a students needs to develop a perspective like an expert in the field to understand all the know-hows of a sector. Prof. Anant Amdekar made the theoretical subject financial regulations interesting by asking few students to volunteer as the researchers and as the market spectators to understand the depth of the topic. # Guest Session On Practical Aspects Of Labour Legislation by Prof. Pradeep Gogte

Mr Pradeep Gogte, has a vivid industry experience of around 38 years in companies such as Godrej & Boyce, Tata Power, Johnson & Johnson etc. These sessions were extremely essential for budding Human Resource professionals to understand the traditional roots of HR. The series of guest lectures conducted by him was structured in such a way that the HR students could a glimpse into the history of evolution of HR in India and its correlation with the various labour laws. All this added up and gave existence to various labour legislations such as The Factories Act, Payment of Wages Act, Maternity Bene-fits Act.

The session covered following key developments in relation to HR and IR:

- Consequences of industrialization and how Industrial Relations were characterised by conflict and cooperation, emerged out of employer-employee relationship
- Characteristics of the Indian IR system and how trade unions were emerged and organised to unite the workmen
- Constitutional provisions to protect the deprived, downtrodden and underprivileged members of society from oppression and exploitation by employers



### Orientation Session for Batch 2021-22

Student orientation programme for MBA course plays an important role in a student's transition as it is first step towards corporate life. Orientation programme is aimed at familiarizing the students about the new normal in education, more about industry opportunities, changes in working environment due to current pandemic situation.
